FLORIDA STATUTES

§209.111 Liability for property of guests.

(1) The operator of a public lodging establishment is not under any obligation to accept for safekeeping any moneys, securities, jewelry or precious stones of any kind belonging to any guest, and, if such are accepted for safekeeping, the operator is not liable for the loss thereof unless such loss was the proximate result of fault or negligence of the operator. The liability of the operator shall be limited to \$1,000 for such loss, if the public lodging establishment gave a receipt for the property (listing the item) on a form which stated, in type large enough to be clearly noticeable, that the public lodging establishment was not liable for any loss exceeding \$1,000 and was only liable for that amount if the loss was the proximate result of fault or negligence of the operator.

(2) The operator of a public lodging establishment is not liable or responsible to any guest for the loss of wearing apparel, goods, or other property, except as provided in subsection (1), unless such loss occurred as the proximate result of fault or negligence of such operator, and, in case of fault or negligence, the operator is not liable for a greater sum than \$500, unless the guest, prior to the loss or damage, filed with the operator an inventory of the guest's effects and the value thereof and the operator is given the opportunity to inspect such effects and check them against such inventory. The operator of a public lodging establishment is not liable or responsible to any guest for the loss of effects listed in such inventory in a total amount exceeding \$1,000.

FOR YOUR SAFETY IN AN EMERGENCY

- If you detect fire or smoke, call "operator."
- If you must leave your room, feel the door to see if it is hot. If it is not hot, open the door slightly to see if you can make it to the nearest evacuation stairwell (shown on the plan across). Stay low to the floor and take your key.
- If the smoke is heavy, seal the door with wet towels. Do not panic. Do not use elevators.

FOR YOUR SECURITY

- Safe deposit boxes are available at the front desk for safeguarding your valuables.
- Be sure to secure your deadbolt lock and security latch.
- Use peephole and fully identify all visitors. If you doubt anyone's identity, please call "operator" for assistance. All employees are required to wear name tags.
- Safeguard and keep your room key with you at all times.
- Insure that all windows, connecting doors, and sliding glass doors are locked.
- This placard explains guest fire safety and security. If you have any questions contact the operator.






